### TRIP CANCELLATION Tour Cost

- Protect your travel investment if you cancel your trip due to a listed reason. Listed reasons include: Sickness, Injury, death, Home made uninhabitable by fire or flood, Traffic accident, Employer termination, Natural Disaster that prevents You from reaching Your Destination, Weather which causes cessation of services of Your Common Carrier.

### OPTIONAL CANCEL FOR ANY REASON Up to 75% Trip Cost

- Not available for residents of Washington State. Only applicable if specifically requested on the application and the appropriate additional premium has been paid. Coverage must be purchased within 14 days of your initial trip deposit.  
- If You purchase the Cancel For Any Reason protection and You cancel Your Trip for any reason not otherwise covered by this policy, the Insurer will reimburse You for up to 75% of the prepaid, forfeited, non-refundable payments or deposits You paid for Your Trip provided You cancel Your Trip more than two (2) days prior to Your Scheduled Departure Date.

### TRIP INTERRUPTION Tour Cost

- Protect your travel investment if you interrupt your trip due to a listed reason.

### TRAVEL DELAY \$500

- Reimburse you for additional accommodations or travel expenses if you are delayed for more than 12 hours.

### LOSS OF BAGGAGE & PERSONAL EFFECTS \$1,000

- Safeguard your luggage if it is lost, stolen or damaged while on your trip.

### BAGGAGE DELAY \$200
